NET CONTROL SCRIPT – NI4CE REPEATER SYSTEM
ROLL CALL AT 0900, 1000, AND 1100 EDT.**

CQ CQ, this is WC4PEM, my name is Christine and I'll be net control for the Simulated Emergency Test Net. We will be doing a roll call for the SET exercise on the NI4CE repeater system at 9, 10, and 11am. After completing roll call, we will be moving to various frequencies to test our communication ability via UHF/VHF and HF. At the end of the test, we will ask you to submit your data to K4KJN. They will be compiling the data and interpreting test results. Each hour we will be testing abilities with specific frequencies. The Test plan is on the West Central Florida website. We have very tight time constraints. If you wish to participate, please keep a log, EVEN IF you can't contact net control. Please print out the log sheet on the West Central Florida website and record your frequency, signal strength, antenna height and what power you are using. This will help us and you know how your station will perform under emergency conditions.

I will call EOCs first, then ECs and AECs by county during this roll call. We will then move to the WC4PEM frequency and do the roll call again, after completing it, we will take general check-ins. If you can't reach WC4PEM, ask the EOC or station nearest you to relay your information.

NET CONTROL SCRIPT – WC4PEM REPEATER SYSTEM – VHF/UHF NET:**

CQ CQ, this is WC4PEM, my name is Kevin and I'll be your net control for the 2M/440 portion of the Simulated Emergency Test Net. This is a directed net, please direct all calls to net control. We will be doing a roll call for the SET exercise on the WC4PEM repeaters every 20 – 30 minutes, depending on the number of stations joining the exercise.

If you wish to participate, please print out the log sheet on the West Central Florida website and record the frequency, signal strength, antenna height and power you are using. Your log is important EVEN IF you can't contact net control. If you can't reach WC4PEM, ask the EOC or station closest to your location listed in the arrlwcfl.org, Special Events section to relay your information. Please record any stations that you hear and give a signal report on their transmission. At the end of the test, we will ask you to submit your data to K4KJN. Her contact information is on the West Central Florida section website.
