However it only takes one strong cold front to put SKYWARN or ARES to work before, during, or afterwards. So always keep inventory on your supplies and check of your equipment just like you would during hurricane season. Also while we are out of hurricane season, this is the time to do improvements to your equipment for the next hurricane season being our chances are lower for activation during the winter months.



#### ARRL NATIONAL PARKS ON THE AIR COMING TO A NATIONAL PARK NEAR YOU.



There has a lot of excitement about this event already. The ARRL is sponsoring the National Parks On The Air (NPOTA). There is only one month left for NPOTA and it comes to an end at 2359 on 12/31/16. This event is not a contest, per se, but a radio operating event similar to Field Day. The event is being held by the ARRL to commemorate the centennial of the National Park Service. There is only one NPA unit in the West Central

# FULL U.S. HOUSE OF REPRESENTATIVES PASS THE AMATEUR RADIO PARITY ACT AND SEND IT ON TO THE U.S. SENATE:



**Update 9/12/16**: The full U.S. House of Representatives voted to suspend their own rules and unanimously approved H.R. 1301, the Amateur Radio Parity Act. The bill has gone to the U.S. Senate for approval. If you have not already done so please contact our two U.S. Senators: Senator Bill Nelson and Senator Marco Rubio. Please urge them to vote for the Senate version (S. 1685) of the Amateur Radio Parity Act. Time is running out because if the bill does not pass the Senate and then is signed by the President before the end of the year, the bill will die because this Congress is coming to a conclusion, and we will be back to square one.

US House Representative <u>Adam Kinzinger</u> (R-IL) introduced the bill on March 4<sup>th</sup> 2015 with 12 original co-sponsors from both sides of the aisle: seven Republicans and five Democrats. US Senator <u>Roger Wicker</u> (R-MS) introduced the companion bill S 1685 on June 26, 2015 with Senator <u>Richard Blumenthal</u> (D-CT) as the original cosponsor, into the United States Senate. HR1301, the original House bill is now up to 126 co-sponsors as of May 12<sup>th</sup>. As of press time, two Representatives with districts that are in the West Central Florida Section: Representative Daniel Webster, 10<sup>th</sup> District, that covers the north central part of Polk County and Representative Tom Rooney, 17<sup>th</sup> District, that covers Charlotte, Desoto, Hardee, Highlands, southeastern Hillsborough, eastern Manatee, and southern Polk Counties.

The following is a quote from the ARRL website, "The Amateur Radio Parity Act would require the FCC to amend its Part 97 Amateur Service rules to apply the three-part test of the <a href="PRB-1">PRB-1</a> federal preemption policy to include homeowners association regulations and deed restrictions, often referred to as 'covenants, conditions, and restrictions' (CC&Rs). At present, PRB-1 only applies to state and local zoning laws and ordinances. The FCC has been reluctant to extend the same legal protections to include private land-use agreements without direction from Congress."
