

ARRL NATIONAL PARKS ON THE AIR COMING TO A NATIONAL PARK NEAR YOU.



There is a lot of excitement about this event already. The ARRL is sponsoring the National Parks On The Air (NPOTA). This event started on January 1, 2016 and will run until December 31, 2016. This event is not a contest, per se, but a radio operating event similar to Field Day. The event is being held by the ARRL to commemorate the centennial of the National Park Service. There are 433 National Park Administrative

(NPA) units in the United States that are eligible for activation. There is only one NPA unit in the West Central Florida Section and it is Desoto National Memorial just north of Bradenton on the shore of the Manatee River. Desoto was activated by the Mid Florida DX Association on New Years Day. You will find a report on this in the March issue of THE WCF PRESSER. However there are four NPA units in the Southern Florida Section and five NPA units in the Northern Florida Sections.

HAMFEST AND SECTION NEWS ROUNDUP

In July and August, I will be disseminating supplements to the July and August issues of THE WCF PRESSER. These supplements will cover some of the past news from the last hamfest season and other events that we have not had a chance to cover in the regular issue of THE WCF PRESSER. Look for those supplements on the Section website with an announcement on the ARRL remailer.

UP TO 5 COSPONSORS IN THE SENATE BILL (S. 1685) AND UP TO 126 COSPONSORS OF THE HOUSE BILL (HR-1301):

Update 5/28/16: To quote the ARRL news article, "After 2-1/2 months of intense negotiations, ARRL has reached an agreement with the Community Associations Institute (<u>CAI</u>) — the national association of homeowners associations — concerning amended language of the <u>Amateur Radio Parity Act</u>. This will allow H.R. 1301 to proceed to what is hoped will be passage of the bill in both houses of Congress this year." In mid November, Senate Bill 1685 (S. 1685), gained three additional co-sponsors, to bring the total co-sponsors to four. House Resolution 1301 (HR 1301), the U.S. House of Representatives version of the Amateur Radio Parity Act, is up to 126 co-sponsors as of May 12th.

US House Representative <u>Adam Kinzinger</u> (R-IL) introduced the bill on March 4th 2015 with 12 original co-sponsors from both sides of the aisle: seven Republicans and five Democrats. US Senator <u>Roger Wicker</u> (R-MS) introduced the companion bill S 1685 on June 26, 2015 with Senator <u>Richard Blumenthal</u> (D-CT) as the original cosponsor, into the United States Senate. HR1301, the original House bill is now up to 126 co-sponsors as of May 12th. As of press time, two Representatives with districts that are in the West Central Florida Section: Representative Daniel Webster, 10th District, that covers the north central part of Polk County and Representative Tom Rooney, 17th District, that covers Charlotte, Desoto, Hardee, Highlands, southeastern Hillsborough, eastern Manatee, and southern Polk Counties.

The following is a quote from the ARRL website, "The Amateur Radio Parity Act would require the FCC to amend its Part 97 Amateur Service rules to apply the three-part test of the PRB-1 federal preemption policy to include homeowners association regulations and deed restrictions, often referred to as 'covenants, conditions, and restrictions' (CC&Rs). At present, PRB-1 only applies to state and local zoning laws and ordinances. The FCC has been reluctant to extend the same legal protections to include private land-use agreements without direction from Congress."

SPECIAL SESSION OF THE EAGLE NET HELD FOR FIELD DAY

On Saturday June 25, a special edition of the Eagle Net, the NTS Traffic Net for the West Central Florida Section which is conducted daily on the NI4CE Repeater System. The net started at 2000, one half hour earlier than scheduled, which was a good thing. The net ran just shy of two hours and handled 19 pieces of NTS Traffic. This traffic included messages to the Section Manager from Field Day sites so they could receive 100 bonus points and messages to thrid parties and other amateur radio operators from Field Day sites, which count for 10 points each under Field Day rules.

A special thanks for Dave Rockwell W4PXE, the substitute NCS and Net Manager for the Eagle Net, for his outstanding job as NCS. Dave was filling in for Christine KK4KJN, who was with Darrell KT4WX on the Field Day Caravan.

HIGHLIGHTS FROM THE MONTH OF JUNE:

On Friday June 17th, Darrell KT4WX, attended the American Victory Ship ARC monthly meeting. This club holds their monthly meetings on board the American Victory Ship, a cargo ship that was in service during the Second World War. The ship is now a museum and is docked in the Port of Tampa. The meeting was held in the crew galley, which was an interesting experience. On Saturday June 25 and Sunday June 26, Darrell Davis KT4WX and Christine Duez KK4KJN conducted the 16th Annual West Central Florida Section Field Day Caravan. The Caravan covered 504 miles, went through all ten counties of the West Central Florida Section, and stopped at 16 Field Day sites. Unfortunately, the Caravan missed three Field Day sties due to them either not operating or their site not accessible during the time their visit was scheduled during the Caravan. Our apologies to these groups for not being able to pay them a visit. The Caravan was running on APRS using the callsign K4WCF-9 and even received two Field Day messages for Darrell via APRS and two others on HF as well. The rest of the Field Day messages were received during a special session of the Eagle Net.
