
#### **HELLO FELLOW AMATEURS**

## **SUMMER 2021 SECTION ARES MEETING HELD IN PERSON AT POLK COUNTY EOC**

The Summer 2021 ARRL West Central Florida Section ARES Meeting, was held on Saturday July 17th, 2021 at 1300, at the Polk County Emergency Operations Center. This was the first in-person Section ARES Meeting since January 2020. Face to face meetings were suspended with the onset of COVID-19 in March 2020, the subsequent quarantine, and unavailability of facilities in which to have a meeting. Section ARES Meetings had been held via Zoom teleconferencing since that time. The ARRL West Central Florida Section ARES Luncheon, that precedes the meeting was held at Sonny's BBO on the west side of Winter Haven for the first time since January 2020 as well.

This was the first Section ARES Meeting that was held as a hybird/in-person meeting with 20 to 25 in attendance, most of the attendance was in person. with several of those in attendance via the Zoom portion of the meeting who due to various circumstances were unable to attend in person. One of the main points of discussion was a refresher on the procedures for deployment of ARES personnel outside of their county via the process that is now standard practice and a reminder that amateur radio operators are not to self deploy. There are also some discussion on the proposed suggestion to chance the name of the "Section Activation" Level" to "Section Alert Level" as the term "Section Activation Level" caused some confusion during the Tropical Storm Elsa incident. It was agreed from this point forward that the Section activation status



would be indicated as "Section Alert Level", due to the fact that the decision to activate a county ARES group is on a local level and not on the Section level.
















### TAMIAMI AMATEUR RADIO CLUB TO HOST A FOXHUNT
