## THE TROPICS ARE STILL ACTIVE. STAY TUNED TO THE TROPICS AND PREPARE FOR THE WINTER SEASON.

We had another potential scare just this last week. Thankfully, a frontal trough came down over the State of Florida and blocked Hurricane Joaquin from paying the United States, or specifically Florida, a visit. Remember the folks and amateur radio operators of the Bahamas affected by Hurricane Joaquin in your thoughts and prayers. This is a reminder that despite of the El Nino, we could still have a late season hurricane. Do not forget that Hurricane Wilma in 2005 and Hurricane Sandy in 2012 were late October hurricanes. Please continue to monitor the daily Tropical Weather Outlooks issued by the National Hurricane Center. Also as we transition out of hurricane season into winter, we do have potential for severe weather from cold fronts early in 2016 due to the El Nino. Continue to occasionally check out your radio equipment and check your supplies in case you are asked to deploy in case ARES is activated.

If you are serving as an ARRL Station Appointee, please be sure to file a monthly report by the 5th day of the month following the month being reported. To those who have been filing their monthly reports, a sincere thank you for your effort. You can fill out te and fill out your monthly report there. Upon successful submission you will receive an on screen confirmation and almost immediately you will receive an email confirmation for your records that also goes to the Cabinet member that oversees your program. Your report is then filed and you are all done for the month. Regular reporting is an ARRL requirement to hold an ARRL Station Appointment.

## AMATEUR RADIO PARITY ACT OF 2015 COMPANION BILL (S 1685) INTRODUCED IN THE SENATE, 99 COSPONSORS OF THE HOUSE BILL (HR-1301):

US House Representative <u>Adam Kinzinger</u> (R-IL) introduced the bill on March 4 with 12 original cosponsors from both sides of the aisle: seven Republicans and five Democrats. US Senator <u>Roger Wicker</u> (R-MS) introduced the companion bill S 1685 on June 26, with Senator <u>Richard Blumenthal</u> (D-CT) as the original cosponsor, into the United States Senate. HR1301, the original House bill is now up to 99 co-sponsors as of October 3. As of July 29<sup>th</sup>, two Representatives with districts that are in the West Central Florida Section: Representative Daniel Webster, 10<sup>th</sup> District, that covers the north central part of Polk County and Representative Tom Rooney, 17<sup>th</sup> District, that covers Charlotte, Desoto, Hardee, Highlands, southeastern Hillsborough, eastern Manatee, and southern Polk Counties.

The following is a summary quote from the ARRL website, "The Amateur Radio Parity Act would require the FCC to amend its Part 97 Amateur Service rules to apply the three-part test of the <u>PRB-1</u> federal pre-emption policy to include homeowners association regulations and deed restrictions, often referred to as 'covenants, conditions, and restrictions' (CC&Rs). At present, PRB-1 only applies to state and local zoning laws and ordinances. The FCC has been reluctant to extend the same legal protections to include private land-use agreements without direction from Congress."

Writing a letter to your Representative or Senator is the best method to ask him to support the Amateur Radio Parity Act. The ARRL is recommending that you send your letter to the ARRL for two reasons: (1) Because of security concerns, it can take from six to eight weeks for a letter sent directly to a Congressional office to be delivered and (2) It can be combined with other letters to your Congressperson and hand-delivered to their office on Capitol Hill.
